Diving Fatality Workshop

Diving is a safe sport, but fatalities occasionally occur which is undesirable in a recreational activity and a risk to the economic health of the industry.

Recently published research by DAN estimated the average fatality rate for insured DAN members to be 16.4 deaths per 100,000 divers. The most common injuries in diving deaths were identified as asphyxia, arterial gas embolism, and cardiac incidents.

These unfortunate events are of concern to the entire diving community and DAN has organized a two-and-a-half day workshop to consider how the occurrence of diving fatalities might be reduced. The objective of this workshop is to develop a consensus for how to reduce the occurrence of recreational compressed gas diving fatalities based on a review of surrounding circumstances.

Goals for the Diving Fatalities Workshop :

1. Learn and discuss how the collection and reporting of data from diving fatality investigations can be improved.
2. Review the factors are most commonly associated with diving fatalities.
3. Discuss how changes to diving training might reduce future fatalities.
4. Evaluate and discuss practice guidelines for cardiovascular fitness in divers.
5. Conduct consensus discussions regarding training and cardiovascular fitness recommendations.

Those who would benefit from participating in the workshop include personnel having responsibilities for training divers, supervising diving operations, conducting medical examinations of divers and diver candidates, and investigating diving accidents.

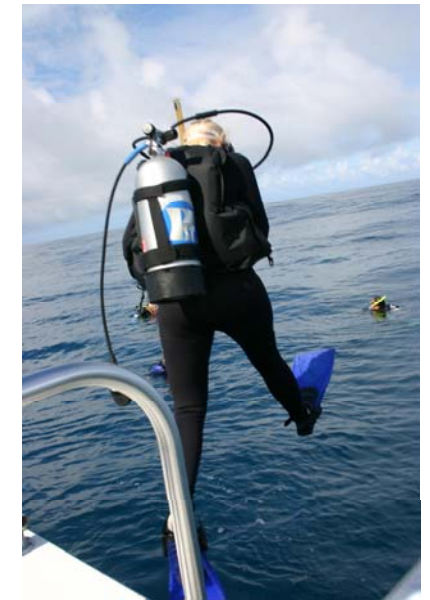
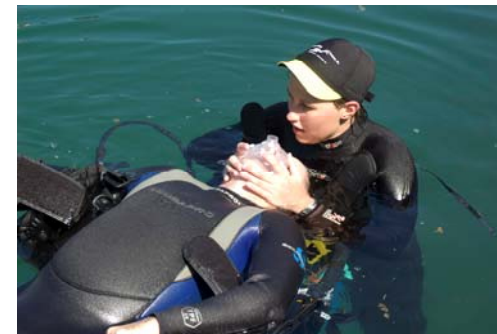
